I. CALL TO ORDER: Meeting was called to order at 4:31 p.m. by John Swiger.

II. GROWTH & DEVELOPMENT: Angela Heinz, VP of Growth and Development presented a proposal to establish a new SJVC campus in the Inland Empire. The team has conducted extensive research, which is provided in the Execution Proposal, which identifies the need for another SJVC campus in the southern California region. Based upon the research, the following programs are proposed for this site:

Business Administration (AS Degree and Certificate)
Medical Assisting (AS Degree and Certificate)
Medical Office Administration (AS Degree and Certificate)
Pharmacy Technology (AS Degree and Certificate)
Heating, Ventilation, Air Conditioning, and Refrigeration (AS Degree and Certificate)
Electrical Technology (AS Degree and Certificate)
Criminal Justice: Corrections (AS Degree and Certificate)

The team is visiting potential locations with the Senior Leadership. An address will be identified by the end of August 2019. The Board asked questions on the ACCJC approval process and the new potential site location and asked about any potential impact to the Ontario Campus. The Board also inquired about establishing additional locations in the north. Angela advised that this is on the horizon but the research pointed to the Southern region first.

Donn moved to approve the new campus and the proposed program offerings. Jill seconded the motion. All in favor.

There being no further business, the meeting adjourned at 5:56 p.m.
