- I. CALL TO ORDER: Meeting was called to order at 4:00 p.m. by John Swiger.
- **II. GROWTH & DEVELOPMENT:** Joseph Holt and Angela Heinz presented the following two proposals for consideration by the Board of Governors. Discussion took place concerning each proposal and action was taken as noted below.
  - **A.** Additional location and program migration: A proposal was presented to extend the Fresno-Aviation Campus by adding a technical suite (additional location) and migrating the following Fresno Campus programs: Industrial

Maintenance Technology; Heating, Ventilation, Air Conditioning, and Refrigeration; and Electrical Technology. Questions were asked and answered concerning the proposal and the following action was taken.

John moved to approve the migration of the following Fresno Campus programs to the Fresno-Aviation Campus: Industrial Maintenance Technology; Heating, Ventilation, Air Conditioning, and Refrigeration; and Electrical Technology and to establish an instructional facility for these three programs to be dubbed as the "Fresno Tech Suite." Jill seconded the motion. All in favor.

B. Project Blue: Joseph provided an overview of the opportunity for SJVCI to acquire Santa Barbara Business College (SBCC). This acquisition provides the opportunity for SJVC to expand into the Santa Maria and Rancho Mirage areas where SBBC currently has campuses. The acquisition also provides an opportunity for the addition of a Vocational Nursing Program at the SJVC Bakersfield Campus (VN program currently taught by SBBC in Bakersfield). Discussion took place on the logistics of these growth initiatives. Angela presented feasibility research results, which were discussed along with the proposed staffing model and budget requirements. Questions were asked and answered concerning the proposal and the following action was taken.

(Mark moved to approve the two new SJVC branch campuses in Santa Maria and Rancho Mirage and the addition of the Licensed Vocational Nursing Program to the SJVC Bakersfield Campus program portfolio. Sue seconded the motion. All in favor.
