The Heating, Ventilation, Air Conditioning, and Refrigeration (HVAC-R) program at SJVC prepares students to work in the heating and cooling industry. Training focuses on theories of heating, refrigeration and air conditioning. Students study the operation, maintenance and repair of residential and commercial equipment.

- How to diagnose mechanical and electrical problems
- Heating and cooling principles
- Electrical theories
- Proper installation, servicing & replacement techniques

## Professional Certifications

Graduates earn a Certificate or Associate of Science degree, and are eligible to sit for the EPA Section 608 Certification.

## Career Information

Well-trained heating and cooling technicians are relied upon to make sure climate control systems are running smoothly. They are responsible for performing these important tasks:

- Installing, servicing & replacing units
- Testing equipment for safety & efficiency
- Upholding compliance with industry standards
- Diagnosing mechanical and electrical problems

## Admission Requirements

Admission to the HVAC-R program requires:

- High school diploma or equivalent
- Wonderlic SLE assessment score of 14 or higher
- Valid California driver license
- No DUI convictions for the past 3 years

Applicants must have reliable plans for transportation, child care and time to devote to academic work outside of scheduled class hours.
