## Hands-On Training

### Students Learn:

- Computerized dental management/charting software
- Interim Therapeutic Restoration (ITR) placement
- Intra-Oral cameras
- Digital and traditional x-ray techniques
- Hand and ultrasonic instruments for advanced scaling and root planing methods



## Professional Certifications

Graduates of the Dental Hygiene program earn an Associate of Science degree and are eligible to take the National Board written examination and a State and/or Regional Board Examination for licensure as a Registered Dental Hygienist. San Joaquin Valley College's Dental Hygiene program is accredited by The American Dental Association, Commission on Dental Accreditation.

### Clinical Hours

Students in the dental hygiene program experience an increasing number of clinical hours as they progress through the program in order to obtain clinical competence. First year dental hygiene students participate in 120 hours of preclinical training during their first term, followed by 136 hours of clinical experience during their second term. During the second academic year, terms 3 and 4, students are scheduled for 204 and 240 hours per term, respectively.

## Career Opportunities

- Evaluate medical and dental health histories
- Provide periodontal therapy through stain, plaque and calculus removal
- Expose and process dental x-rays
- Place interim therapeutic restorations, dental sealants, fluoride, varnish and tooth desensitizing agents
