Construction management professionals can be supervisory level or self-employed managers. Graduates can expect to perform a wide variety of tasks within the industry, including:

- Plan and prepare jobs for clients
- Plan, schedule and control construction projects
- Prepare and deliver presentations
- Manage and supervise construction sites
- Direct and supervise construction or related workers
- Contract or oversee craft work, such as painting or plumbing
- Prepare and submit budget estimates, progress reports, or cost tracking reports
