SECTION 1: INTRODUCTION TO SAN JOAQUIN VALLEY COLLEGE

THE HISTORY OF SAN JOAQUIN VALLEY COLLEGE

STATE DISCLOSURES

REVISION: The State Disclosure for Iowa has been revised, as set forth below. (Catalog p. 11, rev. 8.19.22)

Iowa

SJVC is registered with the Iowa College Student Aid Commission (Iowa College Aid) for its programs offered through the Online Division. Pursuant to Iowa Code Section 261.9(1) "g" Iowa's military deployment tuition and fee refund policy for students is as follows:

A policy to offer not less than the following options to a student who is a member, or the spouse of a member if the member has a dependent child, of the Iowa national guard or reserve forces of the United States and who is ordered to state military service or federal service or duty:

- i. Withdraw from the student's entire registration and receive a full refund of tuition and mandatory fees.
- ii. Make arrangements with the faculty member for the student's course grades, or for incompletes that shall be completed by the student at a later date. If such arrangements are made, the student's registration shall remain intact and tuition and mandatory fees shall be assessed for the courses in full.
- iii. Make arrangements with only some of the faculty teaching courses in which the student was enrolled for grades, or for incompletes that shall be completed by the student at a later date. If such arrangements are made, the registration for those courses shall remain intact and tuition and mandatory fees shall be assessed for those courses. Any course for which arrangements cannot be made for grades or incompletes shall be considered dropped and the tuition and mandatory fees for the course refunded.

Pursuant to Iowa code, tuition reimbursement for non-military Iowa students is as follows: SJVC shall provide to a terminating Iowa student a refund of tuition charges in an amount that is not less than ninety-five percent (95%) of the amount of tuition charged to the student multiplied by the ratio of the remaining number of calendar days in the school period to the total number of calendar days in the school period. SECTION 4: INSTITUTIONAL POLICIES

TECHNOLOGY POLICIES

REVISION: The **Policy Concerning On-Campus Audio, Video, and Photographic Recordings** has been added, as set forth below. (Catalog p. 46, rev. 9.23.22)

Purpose and Scope of Policy

SJVC seeks to promote open communication among faculty, staff, and students, and to protect the integrity of classroom instruction and activities, clinical experiences, and externships. This policy governs all interactions on campus, including, but not limited to, classroom instruction, course materials presented by faculty, student presentations, and counseling sessions as well as off-campus student activities such as clinical instruction and rotations, field trips, and externships.

Audio recording without consent of the other party to the recording is illegal in California pursuant to California's wiretapping law. In the modern age of technology and with the use of mobile devices, "two-party consent" laws are interpreted to require that all participants give their consent to be recorded before recording is permissible. This law does not apply where there is "no expectation of privacy." Faculty, staff, and students enjoy an expectation of privacy inside SJVC's campuses unless advanced consent to record is obtained from participants, or the campus has posted warnings advising that recordings are taking place.

Recording Policy

Unless expressly allowed by the instructor, SJVC prohibits any recording (audio, video or photographic) of a class. Permission to record a class lecture applies exclusively to the student who received permission from the instructor. The recording may not be accessed or utilized by any other individual or replicated without the express permission of the instructor. Recordings shall not be posted to any form of digital media. Students are strictly prohibited from recording seminars by guest lecturers, lab sessions, assessments, field trips, clinicals, externships, any other classroom activities, or any private meetings or conversations among faculty, staff, and students in the academic context.

Accommodated Students

For students who are permitted to make recordings of classes as an approved disability accommodation, authorized recordings may be used only for the purpose of the student's study in the course and may not be replicated or shared with others on or off campus unless the instructor has given express permission to do so. Classes should not be recorded until the Campus President or Campus Director has notified the student that their instructors have been informed that a student with an approved disability accommodation is enrolled in their courses and has permission to record classes. Students needing a disability accommodation, including, but not limited to, the need to record a class session, should contact SJVC's Student Services Coordinator at StudentServicesOffice@sjvc.edu.

Remote Academic Sessions

Disciplinary Action

Failure to adhere to this policy may result in the loss of recording privileges and subject the student to disciplinary actions pursuant to SJVC's Student Code of Conduct.

REVISION: The section entitled **Personal Technology Devices** has been revised, as set forth below. (Catalog, p. 46, rev. 9.23.22)

Following are the guidelines for use of PTDs on campus:

- PTDs must be silenced during class time and may only be used with the express permission of the faculty member teaching the course.
- Students are expected to adhere to the **Policy Concerning On-Campus Audio, Video, and Photographic Recordings** at all times while on campus.
- SJVC assumes no responsibility for lost, stolen, or damaged PTDs.
- Students may not use their PTDs outside the classroom for non-educational purposes while on the SJVC wireless network.
- All terms and conditions of the Computer and Email Use Policies apply to students' use of the SJVC wireless network on their PTDs. See Catalog – Technology Policies.
- Students are not to share the ID and password for the wireless network with non-SJVC users.

ATTENDANCE POLICY

SECTION 7: BACCALAUREATE DEGREE, ASSOCIATE DEGREE, AND CERTIFICATE PROGRAMS

CAREER ACADEMY

REVISION: The Career Services Seminar (CSS 100) has been replaced with the **Career Academy**, an innovative online career-readiness platform in which students earn badges and complete specific tasks in preparation for the job search process. **This revision is in effect beginning with the August 22, 2022 module. As such:**

- Students who are currently enrolled in the CSS 100 course will complete that course.
- Students who are not currently enrolled in CSS 100 but who will come within 15-20 weeks of graduation prior to the August 22 launch may choose to complete either the CSS 100 course or the Career Academy.
- Students who are not enrolled in CSS 100 prior to the August 22 launch may have already completed some tasks in the Career Academy during their program of study. Those students will retain credit for any tasks completed and retain any badges earned.

REVISION: All instances of CSS 100: Career Services Seminar as listed in **Graduation Requirements**, or those denoted as having an equivalent fulfillment course in **Core Course Requirements*** on program description pages have been replaced with **Career Academy**. (Catalog p. 81-165, rev. 7.29.22)

GRADUATION REQUIREMENTS FOR THE BACHELOR OF SCIENCE DEGREE

REVISION: The bullet-listed **Graduation Requirements for the Bachelor of Science Degree** have been revised, as set forth below. All other information remains unchanged. (Catalog p. 77, rev. 7.29.22)

A Bachelor of Science degree will be awarded to students who fulfill the following requirements:

- Completion of a *minimum* of 120 units of coursework; may be combination of transfer units and bridge program
- Completion of program and general education coursework
- 2.0 cumulative grade point average
- Completion of a professional résumé
- Exit interview
- Completion of the prescribed number of Graduate Readiness badges for their program
- Proficiency in General Education as defined below (*see full page for additional information*)

GRADUATION REQUIREMENTS FOR THE ASSOCIATE OF SCIENCE DEGREE

REVISION: Graduation Requirements for the Associate of Science Degree have been revised to reflect the replacement of the Career Services Seminar (CSS 100) with the **Career Academy**, as set forth below. (Catalog p. 135, rev. 7.29.22)

Career Academy

The Career Services Department partners students with the Career Academy to prepare students for the job search process. Utilizing an innovative, interactive hub, students will:

- Engage in a variety of professional development games and activities
- Complete the prescribed number of Graduate Readiness badges for their program
- Create high-quality professional résumés highlighting the skills acquired throughout their program
- Participate in mock interview sessions to develop effective interviewing skills

A final exit interview will capstone the student's preparedness for interviewing with potential employers.

Successful completion of each of these items is a graduation requirement.

Career Academy

- Complete the prescribed number of Graduate Readiness badges for their program
- Create high-quality professional résumés highlighting the skills acquired throughout their program
- Participate in mock interview sessions to develop effective interviewing skills

A final exit interview will capstone the student's preparedness for interviewing with potential employers.

DIAGNOSTIC MEDICAL SONOGRAPHY

CONSTRUCTION MANAGEMENT

REVISION: The program page for the **Bachelor of Science in Construction Management** has been revised, as set forth below. (Catalog p. 69, rev. 7.29.22)

Construction Management

This program is offered through the **Online Division**.

Program Description

The Bachelor of Science degree in Construction Management program prepares graduates to competitively enter the construction management field. Students are provided with comprehensive instruction on a wide variety of topics available to the construction industry, and are trained to prepare competitive project proposals, supervise construction sites, and effectively communicate with clients and workers. Students are prepared for the management responsibilities they will face on the job at construction sites. Freshman applicants (those entering without a previously earned Associate of Science degree in Construction Management) may complete this program in 135 weeks. A bridge option that requires previous completion of an Associate of Science degree in Construction Management is also available and may be completed in 75 weeks.

Program Student Learning Outcomes

Upon completion of this program, the successful student will be able to:

1. Demonstrate effective communication and presentation skills for diverse audiences.
2. Critically evaluate information from multiple sources for application in construction management.
3. Identify emergent issues impacting the construction profession and evaluate solutions utilizing relevant data interpretation techniques.
4. Apply critical thinking to enhance decision-making skills related to the management of residential, commercial, private, and public projects.
5. Apply advanced estimating, scheduling, and financial management skills to ensure the successful outcomes of construction projects.
6. Utilize advanced knowledge of legal and environmental factors to create safe, sustainable, ethical, legally compliant, and lawfully administered projects.

Admission Requirements

To be considered for admission to the Bachelor of Science degree in Construction Management program, applicants must meet the following requirements:

Freshman Applicants

- Must meet all institutional admissions requirements as set forth in Section 2 of the College Catalog

Transfer Applicants

- Hold an Associate of Science degree in Construction Management from an institution of higher learning accredited by an agency that is recognized by the United States Department of Education.
 - All incoming course credit is subject to evaluation for equivalency pursuant to the Transfer of Credit policy as set forth in Section 2 of the College Catalog
- Have successfully completed a minimum of 60.0 units of lower-division coursework

Graduation Requirements: Successful completion of the course requirements with a grade of "C" or higher.

Credential and Professional Certifications

Graduates earn a Bachelor of Science degree in Construction Management.
