#### **Aviation Maintenance Technology Associate Degree**

Graduates earn an Associate of Science degree and are eligible to test for an Airframe and Powerplant (A&P) license through the Federal Aviation Administration (FAA). Federal Aviation Administration certification enables graduates to work in all 50 states.

## **Aviation Maintenance Technology Certificate**

Graduates earn a Certificate of Completion and are eligible to test for an Airframe and Powerplant (A&P) license through the Federal Aviation Administration (FAA) Federal Aviation Administration Certification enables graduates to work in all 50 states.

## **Criminal Justice Corrections Associate Degree**

Graduates earn an Associate of Science degree and the following certifications: Standards and Training for Corrections (STC) Adult Core Academy, which includes 8-hour Baton, and Bureau of Security and Investigative Services (BSIS) certified training in Powers to Arrest, Weapons of Mass Destruction, Firearms\*, Baton, Chemical Agents, Public Relations, Observations and Documentation, Communications and its Significance, and, Liability and Legal Aspects – resulting in (BSIS) Security Guard Card and (BSIS) Security Guard Exposed Weapons permits\*. Students also earn certification in CPR/First Aid.

The BSCC STC Academy only prepares graduates for employment standards in California. The college has not determined state specific standards to work in all corrections position outside of California, and suggests that potential students interested in pursuing employment outside of California investigate standards in other states prior to enrolling in the program.

The BSIS Certifications are valid in California with reciprocity in Florida, Georgia, Louisiana, North Carolina and Oregon.

Licensure is not required to work as a private investigator in Alaska, Idaho, Mississippi or Wyoming.

Individuals seeking licensure as private investigators will need additional training in the following states: Alabama, Arizona, Arkansas, Connecticut, Delaware, Hawaii, Idaho, Illinois, Kentucky, Maine, Maryland, Massachusetts, Michigan, Minnesota, Missouri, Montana, Nebraska, Nevada, New Jersey, New Mexico, New York, North Dakota, Oklahoma, Rhode Island, South Carolina, South Dakota, Tennessee, Texas, Vermont, Virginia, Washington, and West Virginia.



### **Dental Assisting Certificate**

Graduates earn a Certificate of Completion and certifications in Dental Radiation Safety, CPR, Infection Control and Dental Law and Ethics. With the completion of coronal polish and pit and fissure sealants, students are eligible to take the Dental Board of California Examination for state licensure.

Such Licensure is valid for the state of California Only.

Graduates also be allowed to work without license in Alabama, Alaska, Arizona, Arkansas, Colorado, Connecticut, Delaware, Florida, Georgia, Hawaii, Idaho, Illinois, Indiana, Kansas, Kentucky, Louisiana, Maine, Maryland, Michigan, Minnesota, Mississippi, Missouri, Nebraska, Nevada, New Hampshire, New Jersey, New Mexico, New York, North Carolina North Dakota, Ohio, Oregon, Pennsylvania, Rhode Island, South Carolina, South Dakota, Tennessee, Texas, Utah, Vermont, Virginia, Washington, West Virginia, Wisconsin, Wyoming. ## **Dental Hygiene Associates Degree**

Graduates earn an Associate of Science Degree and are eligible to take the National Board written examination and a State and/or Regional Board Examination for licensure as a Registered Dental Hygienist.

Registered Dental Hygienist credentials enable graduates to achieve licensure in all 50 states.

# **Electrical Technology Associate of Science**

Graduates earn an Associate of Science Degree and OSHA 30 and CPR/First Aid certification. Graduates are eligible to take the California General Electrician's Certification Exam, administered by the California Department of Industrial Relations (DiR). In order to be certified as a General Electrician in the State of California, pursuant to certification standards established by the Division of Labor Standards Enforcement, an applicant must pass a certification examination and complete 8000 hours of work for a C-10 electrical contractor installing, constructing or maintaining electrical systems covered by the National Electrical Code. In order to be certified as a General Electrician in the State of California, pursuant to certification standards established by the Division of Labor Standards Enforcement, an applicant must pass a certification examination and complete 8,000 hours of work for a C-10 electrical contractor installing, constructing or maintaining electrical systems covered by the National Electrical Code. ## Heating, Ventilation, Air Conditioning and Refrigeration Associate of Science Degree

Graduates earn an Associate of Science degree and have the opportunity to earn EPA 608 certification. The EPA608 certificate is applicable in all 50 states. Heating, Ventilation, Air Conditioning and Refrigeration Certificate Graduates earn a Certificate of Completion and have the opportunity to earn EPA 608 certification. The EPA608 certificate is applicable in all 50 states.

# Registered Nursing and Registered Nursing LVN-RN Bridge Associate of Science Degree

Graduates earn an Associate of Science Degree in Nursing (ADN) and are eligible to apply to the California Board of Registered Nursing to sit for the National Council Licensure Examination for Registered Nurses

Graduates are eligible to apply to the California Board of Registered Nursing (BRN) to sit for the National Council Licensure Examination for Registered Nurses (NCLEX-RN). This application requires a background check. When applying for licensure in the State of California to the Board of Registered Nursing (BRN), applicants are required to report any disciplinary action against a professional license and/or misdemeanor or felony convictions; certain convictions may result in denial of licensure. Each case is considered individually by the BRN. Graduates who pass the NCLEX-RN are licensed by the BRN and authorized to use the RN credential, which is a requirement to work in this field. Students may use this education combined with a successful completion of the NCLEX-RN exam to pursue licensure in all 50 states. California does not participate in any state licensure compact, so a unique application would be required. Prospective students and current students are strongly encouraged to contact the state professional licensing board or similar regulatory body in the state(s) where they plan to work to determine requirements before enrolling in a program.

## **Respiratory Therapy Associate Degree**

Graduates earn an Associate of Science degree and the following certifications: Basic Life Support (BLS); Advanced Cardiac Life Support (ACLS); Pediatric Advanced Life Support (PALS); and Neonatal Resuscitation Provider (NRP).

Graduates are eligible to sit for the National Board for Respiratory Care (NBRC): Therapist Multiple Choice Exam (TMC). Upon achieving the minimum cut score on the TMC, graduates will be eligible to take the Clinical Simulation Exam (CSE). Upon successfully passing the CSE, the graduate earns the Registered Respiratory Therapy (RRT) credential. The RRT credential is the minimum entry requirement for licensure in California. Graduates who earn the RRT credential by the National Board for Respiratory Care and are licensed by the California Respiratory Care Board are authorized to use the title "Licensed Respiratory Care Practitioner," which is a requirement to work in this field. Registered Respiratory Therapy credentials enables a graduate to achieve licensure in all 50 states.

## **Surgical Technology Associate of Science**

Graduates of this program earn an Associate of Science degree and the following certifications: CPR, HIPAA, and Blood Borne Pathogens. Graduates are also eligible to apply to the National Board of Surgical Technology and Surgical Assisting (NBSTSA) to sit for the Certified Surgical Technologist (CST) national certification exam. Graduates who pass the certification exam are authorized to use the credential Certified Surgical Technologist (CST). Certified Surgical Technologist credentials enable a graduate to achieve licensure in all 50 states.

# **Veterinary Technology Associate of Science**

Graduates earn an Associate of Science degree and are immediately eligible to work as a Veterinary Assistant. This program holds full accreditation by the American Veterinary Medical Association (AVMA), qualifying students to sit for the Veterinary Technician National Examination (VTNE) after graduation. Upon successful completion of the VTNE, graduates are eligible to obtain state licensure and work as a Registered Veterinary Technician (RVT). For more information, please visit http://www.vmb.ca.gov. Registered Veterinary Technicians are credentialed to achieve licensure in all 50 states.

# **Vocational Nursing Associate of Science**

Graduates earn an Associate of Science degree and are eligible to sit for the National Council Licensure Examination for Practical Nurses (NCLEX-PN). Graduates who pass the NCLEX-PN are licensed by the Board of Vocational Nursing and are authorized to the use the credential Licensed Vocational Nurse (LVN), which is a requirement to work in this field Students may use this education combined with a successful completion of the NCLEX-PN exam to pursue licensure in all 50 states. California does not participate in any state licensure compact, so a unique application would be required. Prospective students and current students are strongly encouraged to contact the state professional licensing board or similar regulatory body in the state(s) where they plan to work to determine requirements before enrolling in a program
