RATIONALE FOR ESTABLISHMENT OF NEW CAMPUS IN SAN DIEGO

- There is a large number of unemployed adults within the county
- There is a very large pool of adults in the 20 to 34 year age range
- There is only one program for training Dental Hygienists in San Diego County
- There are large numbers of students at the high school level that will be graduating soon and needing educational opportunities for college enrollment
- Public Universities and Community Colleges have been forced to restrict enrollment numbers due to the continuing State of California budget crisis

LARGE NUMBERS OF UNEMPLOYED IN SAN DIEGO COUNTY

OUICK FACTS- COUNTY OF SAN DIEGO

As of January 1, 2010, The US Census Bureau reported that San Diego County had a population of 3,095,313. In May 2011, The Employment Development Department reported an unemployment rate of 9.6% for San Diego County. The largest city in this county is San Diego, which also has with an unemployment rate of 9.6%. The 2nd largest city is Chula Vista, followed by Oceanside. Chula Vista has a current unemployment rate of 11.2%. Oceanside has an unemployment rate of 9.2%. The three largest cities in San Diego County all have a better unemployment rate than the average for the State of California which stands at 11.4% as of May 2011. Even with low unemployment percentages, over 149,000 people are currently out of work in this county. The following table illustrates the population numbers for the labor force by the county and the largest cities in the region.

LARGE POOL OF FIRST TIME COLLEGE ATTENDERS

The US Census reports that 23.3% of the population of San Diego County is in the age range of 20 to 34 years old. This age range is the typical average age of the traditional SJVC student. The following table illustrates the percentages of population for this age group.

INDIVIDUAL PROGRAM COMPETITION TO SJVC

REGISTERED DENTAL HYGIENIST

There are currently 11 Dental Hygienist programs in the Southern California geographic region. Only one program is located in San Diego County, Southwestern College in National City, California. Vii Besides the program at Southwestern, there are six other community college programs in Southern California: Cerritos College, Cypress College, Oxnard College; Pasadena City College; Riverside City College; and West Los Angeles College. There are two programs at private colleges, one offered by Concord College and one taught at West Coast University. There are also two additional programs that offer baccalaureate degree training for dental hygienists: Loma Linda University and USC. Viii

The following table includes information on the programs located in San Diego County and the southern California region: college name; location of city; distance from the city of San Diego, and cost of the program.

STATE BUDGET CRISIS- REDUCES PUBLIC ACCESS TO EDUCATION

At the time of this report, the State of California is in the midst of a very serious financial crisis. In January 2009, the budget crisis was reported at 14.5 billion, that amount had grown to over 20 billion by June 2009. Now in 2011, the budget deficit is reported at over \$25 billion dollars. xi

The State of California underwrites the cost of public community colleges and also the state universities. With a multi-billion dollar deficit, the State of California has slashed budgets for the California Community College and State University Campus systems for the past several years. At a minimum, the State of California will slash 400 million dollars from the community college system and 500 million from the State University system budgets for the 2011-2012 academic year. With reduced budget funding, comes capped enrollments and fewer openings for new students in the public educational system. This makes the option of attending a private college, much more compelling, and a viable alternative for a growing adult population that is seeking a college education.

The number of students that will be adversely affected by the state budget cuts is continuing to increase each year. In 2010, the State of California budget reduction reduced access to over 140,000 students in the California Community College system. xiii The predicted amount of students that could be denied enrollment for 2011-2012 is significant. The table below tracks the reduced educational access at the California Community College system in the past 2 years. xiv

In San Diego County, there are nine California Community Colleges that serve the population of over 3 million. Over 154,000 students currently attend one of these educational institutions.^{xv} With the budget crisis still in progress, it is difficult to predict the full extent of the student enrollment cuts, but alternate sources need to be in place to serve the geographic area's higher educational needs.

According to the Chancellor's office, Grossmont College has presented their plan to deal with the latest budget cuts. For the Fall of 2011, they will enroll 5,000 fewer students and cut 800 class offerings. If the additional budget cuts go in to effect for California junior colleges, they will restrict a total of 8,000 students from enrolling and cut 1,000 class sessions. xvi

The California State University system has been forced to reduce their budget for the 2011-2012 academic year by \$500 million dollars, due to the California budget crisis. xvii In November 2008, the California State University system released information that over 10,000 students would be cut from their enrollments this year and all 23 of the campus locations would place limits (caps) on enrollments. The latest budget cuts will further lower student enrollments by over 8100 students for the next year. This further limits the number of enrollment choices for first time, freshman and sophomore college students within the public university educational system.

SUMMARY:

Demand exceeds supply for Dental Hygienists in San Diego County

As noted earlier in this report, Southwestern College in Chula Vista, is the only college approved to train Dental Hygienists in San Diego County. Information posted on the IPEDS site for Southwestern reports that the program only graduated 15 students for the past academic year for an average of 24 graduates in the last 5 years.^{xx}

With the predicted annual need of 67 additional dental hygienists in this county, the demand far exceeds the supply for available employees. There is a definite need to establish a new program for Dental Hygienist in San Diego County. San Joaquin Valley College would be serving this region by offering this educational opportunity.
