Dear Dr. Wellsfry:

Last fall I informed you of SJVC's intent to discontinue the Dental Hygiene Program at the SJVC San Diego (Chula Vista) Campus due to market saturation and low enrollments. As the Dental Hygiene Program is the only educational program offered at this site, the program's discontinuation would result in a campus closure as well. The purpose of this letter is to inform you of SJVC's change of plans for this program and campus.

Upon further reflection, SJVC's Senior Management has decided to keep SJVC's options open with respect to the Dental Hygiene program and the San Diego Campus. As such, SJVC has opted to suspend enrollments for the next Dental Hygiene start (04.03.2017). During this period of non-enrollment, SJVC will continue to evaluate its options for this site (e.g., addition of new programs). We anticipate that a decision as to the programs offered and the campus itself will be made by the end of summer 2017.

SJVC will continue to provide the same level of instruction and support services to the two currently enrolled cohorts. The Commission on Dental Accreditation has been informed of this change and has approved the implementation of the non-enrollment plans (see enclosed letter).

We understand as well that we can submit a formal request, if desired, for an additional year of non-enrollment before having our accreditation status discontinued. We will provide an update to the Executive Director of the Dental Hygiene Committee of California informing her of this change.

Dear Dr. Droker,

The purpose of this letter is to provide an update on the status of the SJVC San Diego (Chula Vista) Campus and its single program offering (Dental Hygiene). As you may know, SJVC has been evaluating the options for this site. SJVC first informed the Commission of its plans for the campus in fall of 2016. At that time, I discussed SJVC's intent to discontinue the Dental Hygiene program with former ACCJC Vice President, Norv Wellsfry. In February 2017, a follow-up letter was sent to Dr. Wellsfry informing him of the College's decision to suspend enrollments for the next Dental Hygiene start and further evaluate options for this location.

The program is currently in a *Period of Non-Enrollment*, which has been approved by the programmatic accreditor - American Dental Association's Commission on Dental Accreditation, which is referred to hereinafter as "ADA-CODA" (see encls). SJVC is taking steps to continue that status until the Senior Management reach a final decision about this location and program.

The last student cohort graduated on November 17, 2017. Through a future cohort start is currently not scheduled, the College is maintaining its facility lease until 2020. Consideration is being given to the possibility of transferring the program's "stand-alone" ADA-CODA program accreditation status from the SJVC San Diego Campus to the SJVC Ontario Campus. The program is currently taught at the Ontario Campus as an extension location of the Visalia Campus.

Former students and graduates of the SJVC San Diego Campus may request their records using the same protocol as all other SJVC students. Procedures for requesting official and unofficial transcripts are published in the SJVC Student Handbook and provided herein. Phone calls to the San Diego Campus are routed to the SJVC Call Center for connection to the appropriate party.

Dear Michelle,

In follow-up to your conversation earlier this week with Program Director Amanda Verissimo about patient notification for the SJVC San Diego Dental Hygiene program, I would like to provide you with an update regarding the program's status.

The remaining cohort of students graduated on November 17, 2017. The college desires to continue the program's *Period of Non-Enrollment* status for the approved San Diego location. Though a future cohort start is currently not scheduled, the college has maintained its facility lease and it may keep equipment in place until 2020. This will allow more time for the college Senior Management and supporting staff to explore future cohort options. In addition, more consideration will also be given as to whether to dedicate resources to the program's possible geographical change from the SJVC San Diego Campus to the SJVC Ontario Campus, as discussed in detail this past July between CODA and SJVC representatives. This aligns with our understanding that the program would be discontinued when all first-year positions remain vacant for two (2) consecutive years. We understand as well that we can submit a formal request, if desired, for an additional year of non-enrollment before having our accreditation status discontinued.

The campus and program staff have been working to ensure that all student and clinic records are handled and stored appropriately. In addition, they are now finalizing a system for all former clinic patients to access their records, as needed.

The Commission on Dental Accreditation (CODA) received a report dated November 30, 2017 notifying the Commission of the request for a second year of non-enrollment within the dental hygiene program offered by the San Joaquin Valley College-San Diego in Chula Vista, California. The Commission understands that the remaining cohort of students graduated on November 17, 2017. The program has requested an additional year of non-enrollment in order to explore future cohort options as the college has maintained its facility lease and may keep equipment until 2020. The program is reminded that the accreditation status of programs within the purview of the Commission on Dental Accreditation will be discontinued when all first-year positions remain vacant for two (2) consecutive years. Only one request for continued accreditation will be granted for a total of three (3) consecutive years of non-enrollment.

This change has been noted in the program's permanent file and will be reviewed at the time of the program's next site visit in 2021.

The purpose of this letter is to inform you of the College's decision to close the SJVC San Diego (Chula Vista) Campus and its single program offering (Dental Hygiene). As you may know from our previous communication on this matter, SJVC first informed the Commission of its plans for the campus in fall of 2016. At that time, I discussed SJVC's intent to discontinue the Dental Hygiene program with former ACCJC Vice President, Norv Wellsfry. In February 2017, a follow-up letter was sent to Dr. Wellsfry informing him of the College's decision to suspend enrollments for the next Dental Hygiene start and further evaluate options for this location (enclosure #1).

The College continued to keep the Commission apprised of this evaluation and any resulting decisions concerning this location. In a letter to you, dated February 7, 2018, the College placed the program in a Period of Non-Enrollment, which was approved by the programmatic accreditor - American Dental Association's Commission on Dental Accreditation, which is referred to hereinafter as "ADA-CODA" (enclosure #2). The College was recently notified that its request to have the program's "stand-alone" ADA-CODA program accreditation status has been transferred from the SJVC San Diego Campus to the SJVC Ontario Campus (enclosure #3) was approved.

After thoroughly evaluating its options, the Senior Management have reached the decision to relinquish the approval of the San Diego Campus. Former students and graduates of the SJVC San Diego Campus may request their records using the same protocol as all other SJVC students. (Please note that the last cohort graduated in November 2017.) Procedures for requesting official and unofficial transcripts are published in the SJVC Student Handbook and provided herein. Phone calls to the San Diego Campus are routed to the SJVC Call Center for connection to the appropriate party.

Dear Mr. Perry,

At its August 2, 2018 meeting, the Commission on Dental Accreditation (CODA) granted the dental hygiene program the accreditation status of "approval <u>without</u> reporting requirements." The definitions of accreditation classifications are provided at the link below. Below is a summary of actions and additional information.

Dental Hygiene Program Change

The Commission considered the June 2018 report describing a proposed program change for the dental hygiene program. The Commission noted that the report describes the San Diego campus has been in a period of non-enrollment since March 2017 and the final San Diego cohort graduated in November 2017. It is also noted that San Joaquin Valley College is the sponsor of the San Diego campus; however, the San Diego campus will no longer serve as a major site where educational activity occurs for the Ontario program campus. Therefore, the institutional sponsor has requested a change in the geographic location of the San Diego program located in Chula Vista, California to the Ontario program site as its primary facility located in Ontario, California with enrollment at this location to begin in February 2019.

Following careful review of the information provided, the Commission adopted a resolution to approve the report of program change and continue the program's accreditation status of "approval without reporting requirements." No additional information related to the change is requested from the program at this time. No special focused site visit is warranted at this time. This change will be reviewed at the time of the next site visit for the program scheduled for 2021.
