Hi Janine, Aurora:

On the subject of LLRC LIRN resources, I've had some follow-up with Natalia and I wanted to share the latest so you'll be informed and to confirm your understanding of our needs and Laura's expectation.

Natalia has provided an update of what all in included currently through our existing Gale Silver Core collection and the added features along with additional online resources which we have access to. She has also provided clarification on the increased cost if adding Ovid as a supplement to our current package.

If adding Ovid were to only cost an additional \$500 or a bit more, it would seem like a "why not?" since it's supported by our program staff (and given how it could be shared across programs). However, given that it would actually be an increase of \$11,779 – on top of what we already pay for our Gale Silver Core collection and the added features (\$37,182.50), it just doesn't feel like the right time to ask for it – especially given that we have no clear directive to do so by the BRN, and given Natalia's clarification on what we already do have access to now but are probably not fully using presently in its entirety. I know I would need a stronger case for requesting the additional expense through Senior Management, especially given our tighter economic times of present and for the remainder of the year. My gut tells me that we have enough with our existing subscription.

Please let me know your final thoughts and if you have any different view. I'll then close the loop with Natalia.

Thanks for the responses. Without Ovid, we do have a good variety of online journals and databases. Below is a screen shot of what is available:



Gale Virtual Reference Library and eBrary together gives us nearly 140,000 resources (although there are other topics included in there aside from health and medical). The nursing and allied health collection has 2,000 titles (1300 are full-text). The Health and Wellness Resource Center databases has 1300 journals and 2200 general interest publications. So, I think we have a good amount of resources to offer the RN program. I was hearing that the visiting team from the BRN was recommending ProQuest; that's why I started investigating the cost of adding ProQuest or Ovid as an alternative to ProQuest. Janine's response seems to indicate that our current online resources are sufficient.

The rest of the LRC staff are happy with our current subscription; most agreed that if we could add-on, they'd be interested in adding on Ovid. With the responses we got—and taking a look at what we already have—I support staying with our current subscription and not adding on ProQuest or Ovid. What is your opinion? I've included the price breakdown of each subscription:

Renewal for current subscription (Gale Silver Core Collection including eBrary and Statista): \$37, 182.50

Gale Silver Core Collection with ProQuest add-ons: \$56800 Gale Silver Core Collection with Ovid: \$48961.50

Natalia Dominguez is our CAO coordinator over the campus LRCs and she has reached out regarding updates that will benefit the RN program (driven in part by Laura's visit in June). Please see Natalia's questions posed through the dialogue below.

I had stepped out of the LRC during part of the time in which Laura was there speaking with the Ontario LRC Coordinator. I'm hoping, Aurora, that your memory of what Laura shared (regarding electronic resources) can help guide our discussion moving forward. My hunch is similar to Natalia's shared below – that is, Laura may be more familiar with ProQuest and she may likely not have been as familiar with Gale and all the offerings which our RN staff and students currently have available through it. Likewise, I suspect that Laura did not have the time to sit down and review of all Gale's features and resources specific to the RN program. Per Natalia's update below, it's great that the Gale Silver Core package will now be enhanced by the eBrary addition. Adding the Ovid Nursing Collection may be a nice alternative as well – and, as Natalia points out, it would benefit more than just the RN program. In addition to MA, the Visalia Campus LVN program could no doubt benefit as well with this update (as may other programs across our campuses).

Aurora, do you recall whether Laura stated that we must have ProQuest or did she possibly say that it would be most helpful to have a resource very similar to ProQuest (which Natalia feels we can have with the Ovid update, along with what's already offered through our current Gale subscription and the added eBrary)?

Both your thoughts and content-expert input would be appreciated.

Hi Crystal and Greg,

We are currently in the process of renewing our LIRN subscription. This year, eBrary is now included into our Gale Silver Core package, which means that we will not have to purchase it separately, allowing us to save some money (total price is \$37,182.50) and possibly give us the chance to add on

an additional resource offered through LIRN.

I know the Ontario campus recently had a visit from the BRN accreditation team. Our Ontario LRC said one of the recommendations was to subscribe to ProQuest (which is available through LIRN). Rochelle and I both looked at the ProQuest LIRN package and we have some concerns. If we were to switch entirely to ProQuest, we would have access to fewer databases. Most of the databases offered through ProQuest are already offered through Gale—and again, Gale gives us more databases. We do have the option of adding on a ProQuest collection of databases (not available in Gale) to our current Gale Silver Core package; this would bring our LIRN subscription cost up to \$56,800.

Another option was looking into an additional resource to add on to our current package (Gale Silver Core). One of the collections that several LRCs were interested in was the Ovid Nursing Full-Text Plus Journal collection. This collection includes 47 full-text nursing journals that can be used not only for the RN, but the MA program as well. If we added this on to our current package the subscription cost would increase to \$48,961.50.

So, my question is this: how firmly do we have to follow accreditation team recommendations? Do we absolutely need to add on ProQuest, or is it acceptable to say that we looked into adding on ProQuest, but felt that the Ovid Nursing collection was the better selection for our college? My other worry is that I don't know what the exact recommendation was. Is the recommendation to use ProQuest because that's what the team prefers and they didn't understand what database collections we offer? Or, do they think we need additional nursing resources and felt that ProQuest would be able to fulfil that need?

What are your thoughts?
