

AMERICAN MEDICAL ASSOCIATION ("AMA") - SITE LICENSE TERMS & CONDITIONS ("T's & C's")

These T's & C's constitute a legally binding agreement between the Licensee and AMA. The Licensee represents that the person agreeing to these T's & C's has the authority to enter into this License on behalf of Licensee's organization. If Licensee accepts these Terms, please sign as indicated below and return a copy to the AMA.

"Authorized Sites" means those geographic locations identified in AMA's quotation to Licensee attached hereto ("Quote").

"Authorized Users" means the Licensee and those individuals authorized by Licensee to access the Licensed Materials through Licensee's Secured Network.

"Effective Date" means the commencement date of the Subscription Term as set forth in AMA's invoice.

"Licensee" means the entity identified on the signature page of these T's & C's.

"Licensed Materials" means the electronic versions of AMA publications identified in AMA's Quote.

"License Fee" means the fee specified for the applicable Subscription Term as set forth in AMA's Quote (for the initial Subscription Term), or in AMA's invoice or renewal notice (for any renewal Subscription Term).

"Licensee's Secured Network" means a network maintained or controlled by Licensee that is accessible only to Authorized Users who are (i) at the Authorized Sites; and/or (ii) whose identity is authenticated by Licensee at the time of login.

"Subscription Term" means one (1) year periods commencing on the Effective Date and continuing from year to year thereafter until the T's & C's are terminated.

1. **Grant of License.** In consideration of Licensec's payment of the License Fee and acceptance of the T'S & C'S, AMA grants to Authorized Users a limited, non-exclusive, non-transferable license to access and use the Licensed Materials solely via the Licensee's Secured Network during the Subscription Term.

2. **Ownership of Licensed Materials.** The Licensed Materials, including all copyrights and other intellectual property rights, are the sole and exclusive property of the AMA. The only rights granted to Authorized Users are the rights to access and use the Licensed Materials in accordance with the T's & C's. All rights not specifically granted herein are reserved by the AMA.

3. **Permitted Uses.** Authorized Users shall access and use the Licensed Materials in compliance with all applicable laws and solely for personal, non-commercial purposes related to research, education and private study. Permitted uses include the right to search, view, and display the Licensed Materials; print and download individual articles; and distribute electronic or print copies of individual articles to other Authorized Users. All other access to or use of the Licensed Materials is strictly prohibited including (i) any distribution or transmission of any or all of the Licensed Materials for commercial purposes or on any public bulletin boards, web sites, or internet chat rooms, and (ii) the creation of a database or compilation containing any or all of the Licensed Materials or otherwise storing any of the Licensed Materials in any retrieval system. Except as permitted herein or by U.S. fair use law, AMA's prior written permission is required for all other copying, reproduction, or republication of the Licensed Materials. Permission requests shall be directed to <u>www.copyright.com</u> or to AMA's Permissions Department.

4. Academic Institutions. If Licensee is an academic institution, it may (a) supply single copies of articles from the Licensed Materials to a noncommercial library located in the same country as Licensee by mail, fax or secure electronic transmission in accordance with Section 108 of the United States Copyright Act and with guidelines developed by the National Commission of New Technological Uses of Copyrighted Works (CONTU); and (b) incorporate individual articles from the Licensed Materials into electronic course packs, so long as Licensee deletes the Licensed Materials from electronic course packs at the end of the academic year in which they were used.

5. Licensee Obligations. Licensee shall: (a) take reasonable steps to ensure that only Authorized Users are permitted to access the Licensed Materials and that Authorized Users comply with the T's & C's; (b) promptly notify AMA of any use outside the scope of the license granted in Section 1 or other breach of the T's & C's; and (c) pay any applicable taxes and fees arising out of Licensee's use of the Licensed Materials and/or the rights granted under the T's & C's. Licensee shall inform AMA immediately upon becoming aware of any unauthorized access to the Licensed Materials and cooperate with AMA to promptly resolve such matter. In addition to any other applicable remedies, AMA may limit, deny, suspend, or terminate access to the Licensed Materials without liability to Licensee if unauthorized access to the Licensed Materials is detected or suspected, or in the event an Authorized User violates the T's & C's.

6. **Payment.** Licensee shall pay AMA the License Fee for the applicable Subscription Term. The License Fee shall be (i) paid in United States Dollars (US\$), (ii) drawn on a United States Bank, and (iii) made without deduction or withholdings of any kind including but not limited to taxes.

7. Termination; Continued Access. The T's & C's and the rights granted to Licensee hereunder will terminate automatically if Licensee does not pay the License Fee for the applicable Subscription Term. Licensee may terminate its License at any time by discontinuing access to and use of the Licensed Materials in which case Licensee shall not be eligible for a refund. AMA reserves the right to suspend or terminate Licensee's rights hereunder without cause upon notice to Licensee in which event Licensee may be entitled to a prorata refund of the License Fee. Except for termination due to a breach of these T's & C's by an Authorized User, upon termination or expiration of these T's & C's AMA shall make commercially reasonable efforts to provide continuing access to Authorized Users to that portion of the Licensed Materials subscribed to, and paid for, by Licensee hereunder. Such access shall be further subject to (i) these T's & C's (except for the payment of a License Fee); (ii) AMA's continued right to grant the rights hereunder; and (iii) AMA's right to provide such access either, at AMA's option, through (x) a computer network owned and operated by AMA at no cost to Licensee, or (y) an AMA approved central archiving facility or other third party either of which may or may not charge a fee. The right to access the Licensed Materials granted hereunder shall automatically terminate in the event of a natural disaster or other event that renders AMA and any of its successors or assigns, and/or any of its authorized third party service providers, permanently and completely unable to provide Licensee with access to the Licensed Materials as contemplated herein. In such event, Licensee (i) shall have the right to access the Licensed Materials through CLOCKSS, (ii) have the right to store and make the Licensed Materials available on its own server for use by Authorized Users and (iii) shall not be entitled to any refund of License Fees paid hereunder.

8. Limitation of Liability. TO THE MAXIMUM EXTENT PERMITTED BY LAW (A) THE LICENSED MATERIALS ARE PROVIDED "AS IS" ON AN "AS AVAILABLE BASIS" WITHOUT REPRESENTATION OR WARRANTY OF ANY KIND, EITHER EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, AND NONINFRINGEMENT AND (B) AMA'S LIABILITY HEREUNDER SHALL NOT EXCEED THE AMOUNT OF THE MOST RECENT ANNUAL LICENSE FEE PAID BY LICENSEE. IN NO EVENT SHALL AMA, ITS EMPLOYEES, MEMBERS, TRUSTEES, AGENTS, SUPPPLIERS OR LICENSORS BE LIABLE FOR ANY SPECIAL, INCIDENTAL, INDIRECT, OR CONSEQUENTIAL DAMAGES OF ANY KIND OR ANY DAMAGES RESULTING FROM THE INABILITY TO USE, OR THE USE OF, THE LICENSED MATERIALS, WHETHER OR NOT ADVISED OF THE POSSIBILITY OF DAMAGES, OR ON ANY THEORY OF LIABILITY.

9. Choice of Law/Venue. The T's & C's shall be construed and enforced in accordance with the internal laws of the State of Illinois without regard to its choice of law principles. Any controversy or claim arising out of or relating to the T'S & C'S shall be brought in the courts of the State of Illinois located in Chicago, IL or United States District Court for the Northern District of Illinois and the parties consent to the jurisdiction of such courts. The foregoing shall not apply if Licensee is a public institution or agency and compliance would violate (i) a statute or regulation applicable to Licensee; or (ii) a bylaw or equivalent governing instrument of Licensee.

10. Other Provisions. (a) AMA may modify, discontinue or otherwise remove any articles or other materials from the Licensed Materials. In the event AMA makes a material change in the Licensed Materials, Licensee may terminate access to and use of the Licensed Materials and, upon prompt written notice to AMA of such termination, receive a refund of the License Fee for the unexpired portion of the Subscription Term. (b) The T's & C's represent the entire understanding of the parties with respect to the Licensed Materials. Any terms offered by Licensee that are in addition to, different from, or in conflict with the T's & C's shall be deemed a material alteration and are rejected. (c) Licensee shall not assign these T's & C's or any of Licensee's rights or obligations hereunder without the prior written consent of AMA which will not be unreasonably withheld. (d) In the event that any portion of the T's & C's are deemed to be invalid or illegal, then such invalid or illegal portion shall not affect the validity or legality of the remainder of the T's & C's. (e) The failure of either party to enforce any right or obligation hereunder. (f) Sections 6, 8, 9, and 10 shall survive expiration of the License or termination of the T's & C's. (g) Any notice which must or may be given hereunder shall be in writing, in English, and shall be deemed delivered when personally delivered, delivered by an overnight express courier service, delivered by confirmed

facsimile transmission followed by a hard copy or placed in the United State Mail certified mail, return receipt requested, and properly addressed as follows: If to AMA, notices shall be sent to the Senior Vice President and Publisher, Periodic Publishing, American Medical Association, 330 North Wabash Avenue, Suite 39300, Chicago, Illinois 60611-5885 (Fax # (312) 224-6904); with a copy to the Office of General Counsel at the same address (Fax # (312) 224-6924). If to Licensee, notices shall be sent to attention of the person and at the address specified in AMA's invoice. (h) In case of any conflict between the English language and any translated version of the T's & C's, the English language version shall govern and shall be used exclusively in connection with the interpretation and construction of any of the words, phrases, and/or provisions of the T's & C's.

Licensee's access to the Licensed Materials will not begin until Licensee's authorized representative accepts these T's & C's. Upon receipt of Licensee's acceptance, AMA shall issue an invoice which will include the Effective Date of Licensee's Subscription Term. ELSEVIER SUBSCRIPTION AGREEMENT

This agreement ("Agreement") is entered into as of 17 October 2016 by and between **San Joaquin Valley College**, 3828 W.Caldwell Ave, Visalia, CA 93277, USA (the "Subscriber"), and **Elsevier B.V.**, Radarweg 29, 1043 NX Amsterdam, The Netherlands ("Elsevier").

The parties hereto agree as follows:

SECTION 1. SUBSCRIPTION.

1.1 Subscribed Products.

Elsevier hereby grants to the Subscriber the non-exclusive, non-transferable right to access and use the products and services identified in Schedule 1 ("Subscribed Products") and provide the Subscribed Products to its Authorized Users (as defined herein) subject to the terms and conditions of this Agreement.

1.2 Authorized Users/Sites.

Authorized Users are the full-time and part-time students, faculty, staff and researchers of the Subscriber and individuals who are independent contractors or are employed by independent contractors of the Subscriber affiliated with the Subscriber's locations listed on Schedule 2 (the "Sites") and individuals using computer terminals within the library facilities at the Sites permitted by the Subscriber to access the Subscribed Products for purposes of personal research, education or other non-corporate use ("Walk-in Users").

1.3 Authorized Uses.

Each Authorized User may:

- access, search, browse and view the Subscribed Products;
- print, download and store a reasonable portion of individual items from the Subscribed Products for the exclusive use of such Authorized User
- incorporate links to the Subscribed Products on the Subscriber's intranet and internet websites and in electronic coursepacks, reserves and course management systems and instructor websites, provided that the appearance of such links and/or statements accompanying such links will be changed as reasonably requested by Elsevier
- store individual journal articles from the ScienceDirect Subscribed Products in the private library of a social networking site for the Authorized User's own personal use only;
- share individual journal articles from the ScienceDirect Subscribed Products with third party colleagues individually for their scholarly or research use;
- share individual journal articles from the ScienceDirect Subscribed Products with a limited number of third party colleagues as part of an invitation only working group on non-commercial platforms or tools, for personal, scholarly or research use; and
- access, search, browse, view, print, make electronic copies and store for the exclusive use of such Authorized User or, if the Authorized User is a librarian/information specialist, for the exclusive use of another Authorized User certain journal articles and book chapters from the ScienceDirect® online service that are not subscribed to as part of the Subscribed Products, with each twenty-four (24) hour access period for a selected article or chapter, a "Transaction".

The Subscriber may:

deliver book chapters from the Subscribed Products to fulfill requests as part of the practice commonly known as "interlibrary loan" from non-commercial libraries located within the United States, provided that the Subscriber's staff reviews the requests and fulfills the requests in compliance with Section 108 of the U.S. Copyright Law (17 U.S.C. § 108) and the Guidelines for the Proviso of Subsection 108(g)(2) (Final Report of the National Commission on New Technological Uses of Copyrighted Works, 1978).

The Subscriber:

(i) may extract and index Data (as defined below) from the articles authored by Authorized Users included in the Subscribed Products, to index in the user interface of the Subscriber's product by implementing both the SD Search API and the SD Article Entitlement API (see http://dev.elsevier.com/sd_apis.html), and store in perpetuity in the Subscriber's secure database system that the Subscriber uses to collect, preserve and disseminate information about the intellectual output of the Subscriber's institute(s) ("Institutional Repository") and to publically display Snippets (as defined below), provided that:

(a) the display of any Data will at all times include (if available) the associated Digital Object Identifier ("DOI"), and

(b) links are incorporated in the Data to the relevant article landing page in the Subscribed Product from which such Data was extracted by which such link to the Subscribed Product is displayed more prominently than the links to other versions of the article, and

(c) the indexes only include Data and no other parts of the full text articles, and

(d) the Subscriber will provide on a monthly basis to Elsevier complete and accurate usage data reports on the Subscriber's Institutional Repository usage activity in a mutually agreed upon format which will at a minimum specify preprint and author manuscripts usage, during the pilot period of six (6) months.

• (ii) is obligated to remove illicit versions of full text articles upon Elsevier's request and allow Elsevier to review the implementation of the Data into the Institutional Repository. Elsevier will have the right to suggest improvements to the display and ranking of the search results for the articles that are available in ScienceDirect.

"Data" will be limited to the following: index terms, bibliographic information, headers, references, digital object identifiers, footnotes, acknowledgements, keywords, author affiliation, Snippets (as defined below) and abstracts, or any other data when included, of the full text articles. Abstracts may only be displayed on the abstract records on the Subscriber data's websites, all other services of the Institutional Repository, such as (but not limited to) alerts, e-mail services and API's may only display Snippets but not abstracts.

"Snippets" mean a first page PDF preview of the full text article or short contextually relevant query-dependent text or data which may include bibliographic metadata as well as a maximum of 120 words of query-dependent text from individual full text articles.

1.4 *Restrictions on Use of Subscribed Products.*

Except as expressly stated in this Agreement or otherwise permitted in writing by Elsevier, the Subscriber and its Authorized Users may not:

- abridge, modify, translate or create any derivative work based on the Subscribed Products, except to the extent necessary to make them perceptible on a computer screen to Authorized Users;
- remove, obscure or modify in any way any copyright notices, other notices or disclaimers as they appear in the Subscribed Products;
- use any robots, spiders, crawlers or other automated downloading programs, algorithms or devices to continuously and automatically search, scrape, extract, deep link, index or disrupt the working of the Subscribed Products;
- substantially or systematically reproduce, retain, redistribute or disseminate online the Subscribed Products; or
- post individual items from the Subscribed Products on social networking sites.

Authorized Users who are individuals who are independent contractors or are employed by independent contractors may use the Subscribed Products only for the purposes of the contracted research work for the Subscriber.

1.5 Intellectual Property Ownership.

The Subscriber acknowledges that all right, title and interest in and to the Subscribed Products remain with Elsevier and its suppliers, except as expressly set forth in this Agreement, and that the unauthorized redistribution or dissemination online of the Subscribed Products could materially and irreparably harm Elsevier and its suppliers.

SECTION 2. ELSEVIER PERFORMANCE OBLIGATIONS.

2.1 *Access to Subscribed Products.*

Elsevier will make the Subscribed Products accessible to the Subscriber and its Authorized Users from the internet address set forth on Schedule 1 or as may be otherwise set forth herein.

2.2 *Quality of Service*.

Elsevier will use reasonable efforts to provide the Subscribed Products with a quality of service consistent with industry standards, specifically, to provide continuous service with an average of 98% up-time per year, with the 2% down-time including scheduled maintenance and repairs performed at a time to minimize inconvenience to the Subscriber and its Authorized Users, and to restore service as soon as possible in the event of an interruption or suspension of service.

2.3 Withdrawal of Content.

Elsevier reserves the right to withdraw from the Subscribed Products content that it no longer retains the right to provide or that it has reasonable grounds to believe is unlawful, harmful, false or infringing.

2.4 Usage Data Reports.

Elsevier will make usage data reports on the Subscriber's usage activity available as described at <u>https://www.elsevier.com/sd_usage_reports</u>.

SECTION 3. SUBSCRIBER PERFORMANCE OBLIGATIONS.

3.1 *Authentication*.

Access to the Subscribed Products will be authenticated by the use of Internet Protocol ("IP") address(es) and/or usernames and passwords and/or a delegated authentication mechanism requiring at least two different credentials, as identified on Schedule 2. Distribution of usernames, passwords, credentials or otherwise providing remote access to the Subscribed Products by Authorized Users who are Walk-in Users is not permitted.

3.2 *Protection from Unauthorized Access and Use.* The Subscriber will use reasonable efforts to:

- limit access to and use of the Subscribed Products to Authorized Users and notify all Authorized Users of the usage restrictions set forth in this Agreement and that they must comply with such restrictions;
- issue any passwords or credentials used to access the Subscribed Products only to Authorized Users, not divulge any passwords or credentials to any third party, and notify all Authorized Users not to divulge any passwords or credentials to any third party;
- provide true, complete and accurate IP addresses, as identified on Schedule 2, (if any) for the exclusive use by the Subscriber (including, if requested by Elsevier, written confirmation by the relevant third party internet service provider) and proactively inform Elsevier of any changes to the Subscriber IP addresses, including the addresses no longer being used exclusively by the Subscriber; and
- promptly upon becoming aware of any unauthorized use of the Subscribed Products, inform Elsevier and take appropriate steps to end such activity and to prevent any recurrence.

In the event of any unauthorized use of the Subscribed Products, Elsevier may suspend the access and/or require that the Subscriber suspend the access from where the unauthorized use occurred upon notice to the Subscriber. The Subscriber will not be liable for unauthorized use of the Subscribed Products by any Authorized Users provided that the unauthorized use did not result from the Subscriber's own negligence or willful misconduct and that the Subscriber did not permit such unauthorized use to continue after having actual notice thereof. The Subscriber will be responsible for the adherence to the terms and conditions of this Agreement by a third party provider the Subscriber engages, in particular, if such third party provider supplies and manages IP addresses.

3.3 *Compliance with Sanction Laws.*

Elsevier reserves the right to deny access to the Subscribed Products to any person or entity who is prohibited from receiving such access based on any applicable sanctions or embargoes laws.

SECTION 4. FEES AND PAYMENT TERMS.

The Subscriber will pay to Elsevier the fees set forth in Schedule 1 (the "Fees") within thirty (30) days of date of invoice. Late payments will be subject to interest charges of 1% per month on the unpaid balance. The Fees will be exclusive of any sales, use, value added, withholding or similar tax and the Subscriber will be liable for any such taxes in addition to the Fees.

SECTION 5. TERM.

5.1 *Term*.

The term of this Agreement will commence on 01 January 2017 and continue until 31 December 2017 ("Initial Term").

5.2 *Renewal.*

After the Initial Term, this Agreement will be automatically renewed for successive one-year terms (each a "Renewal Term"), and the Fees will be increased by the then current standard Elsevier price increase, unless either party gives notice to the other by 1 August prior to the end of the then current term that it does not intend to renew. The Initial Term and each Renewal Term are collectively the "Term".

SECTION 6. ELSEVIER WARRANTIES AND INDEMNITIES.

6.1 Warranties.

Elsevier warrants that use of the Subscribed Products in accordance with the terms and conditions herein will not infringe the intellectual property rights of any third party.

6.2 *Indemnities*.

6.4 *Limitation of Liability.*


